CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

E. D. GRASSMAN

confirms the right to use the waters of A WELL in the CASE CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 294.3 ACRES.

This right was perfected under Permit G-8218. The date of priority is JUNE 15, 1978. This right is limited to 1.73 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, SECTION 23, T 4 S, R 2 W, W.M.; 2750 FEET SOUTH AND 2060 FEET EAST FROM THE SW CORNER OF DLC 45.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The user shall maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
