## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BARKER RANCHES RT. 1, BOX 113 HAINES, OR 97833

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of NORTH POWDER RIVER, for IRRIGATION OF 15.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 446.2 ACRES.

This right was perfected under Permit 19907. The date of priority is JUNE 21, 1950. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.5 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 11; NW 1/4 NE 1/4 AND SE 1/4 NW 1/4, SECTION 14, T 7 S, R 38 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acrefeet per acre for each acre irrigated during the irrigation season of each year AND SHALL BE FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED 2.5 CFS.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
