CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RONALD A. WALCH 10399 S. FORK LITTLE BUTTE CREEK ROAD EAGLE POINT, OREGON 97524

confirms the right to use the waters of TWO SPRINGS, tributaries of SOUTH FORK LITTLE BUTTE CREEK, for IRRIGATING 0.75 ACRE AND DOMESTIC USE FOR ONE FAMILY INCLUDING THE IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN.

This right was perfected under Permit 49400. The date of priority is OCTOBER 18, 1984, FOR DOMESTIC USE AND DECEMBER 28, 1984, FOR IRRIGATION USE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 8.7 GALLONS PER MINUTE, BEING 2.1 GPM FROM EACH SPRING FOR IRRIGATION AND 2.2 GPM FROM SPRING 1 AND 2.3 GPM FROM SPRING 2 FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 7, T 37 S, R 3 E, W.M.; SPRING 1 - 1050 FEET NORTH AND 320 FEET EAST; SPRING 2 - 1130 FEET NORTH AND 390 FEET EAST; BOTH FROM THE SOUTHWEST CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NW 1/4 0.75 ACRE AND DOMESTIC SECTION 18
TOWNSHIP 37 SOUTH, RANGE 3 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
