CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES WILLIAM VAN SICKLE 3578 UPPER COW CREEK ROAD AZALEA, OREGON 97410

confirms the right to use the waters of COW CREEK, a tributary of SOUTH UMPQUA RIVER, for IRRIGATING 1.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DOUGLAS County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 11, at Page 1. The date of priority is SEPTEMBER 30, 1907.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed THE RATE OF ONE CUBIC FOOT OF WATER PER SECOND OF TIME FOR EACH 70 ACRES OF LAND IRRIGATED DURING THE IRRIGATION SEASON.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SECTION 5, T 32 S, R 4 W, W.M.; DIVERSION 1 - 410 FEET SOUTH AND 2270 FEET EAST; DIVERSION 2 - 460 FEET SOUTH AND 2430 FEET EAST; BOTH FROM THE WEST QUARTER CORNER OF SECTION 5.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed ONE-SEVENTIETH cubic foot per second per acre irrigated during the irrigation season.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 1.6 ACRES SECTION 5 TOWNSHIP 32 SOUTH, RANGE 4 WEST, W.M.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 15, 1987, and together with Certificate 56468, supersedes Certificate 9677, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
