CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRED AND MARTHA RAPP TALENT, OREGON

confirms the right to use the waters of WAGNER CREEK, a tributary of BEAR CREEK, for DOMESTIC, STOCK, AND IRRIGATION OF 44.04 ACRES, BEING 1.8 ACRES WITH 1852 PRIORITY, 20.94 ACRES WITH 1854 PRIORITY, AND 21.3 ACRES WITH 1864 PRIORITY.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The dates of priority are 1852 - WAGNER AND THORNTON DITCH, 1854 - ROCKEFELLOW DITCH, AND 1864 - DAVENPORT DITCH.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.02 CUBIC FOOT PER SECOND (CFS) WITH 1852 PRIORITY, 0.24 CFS WITH 1854 PRIORITY, AND 1.25 CFS WITH 1864 PRIORITY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WAGNER AND THORTON DITCH, ROCKEFELLOW DITCH, AND DAVENPORT DITCH.
