confirms the right to use the waters of Snow Creek and Three Creeks, tributaries of Squaw Creek for irrigation of 109.0 acres, storage, stock and domestic use.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 20. The dates of priority are the 1886, 1891 and 1897.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.5 acre-feet, including the loss by seepage from the diversion points to the lands, for each acre irrigated during the irrigation season of each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.
