CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CORINNA B. HITTLE

CHICAGO, ILLINOIS 60607

confirms the right to use the waters of TOLMAN CREEK, a tributary of NEIL CREEK, for IRRIGATION OF 12.0 ACRES AND DOMESTIC USE IN TRACT 1 AND IRRIGATION OF 1.2 ACRES IN TRACT 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1853.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 CUBIC FOOT PER SECOND FOR TRACT 1 AND 0.014 CUBIC FOOT PER SECOND FOR TRACT 2, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows: SE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 14, T 39 S, R 1 E, W.M.; 140 FEET NORTH AND 430 FEET WEST FROM THE SE CORNER OF SECTION 14 FOR TRACT 1 AND IN THE NW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 13, T 39 S, R 1 E, W.M.; 1330 FEET NORTH AND 1140 FEET EAST FROM THE SW CORNER OF SECTION 13 FOR TRACT 2.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 39 SOUTH, RANGE 1 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate , State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUN 20 1997 , approving Transfer Application 7733.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
