confirms the right to use the waters of 2 SPRINGS, FIELD DRAIN TILE AND RESERVOIR CONSTRUCTED UNDER PERMIT R-5037, tributaries of the EAST FORK DAIRY CREEK, for SUPPLEMENTAL IRRIGATION OF 30.8 ACRES.

This right was perfected under Permit 32760. The date of priority is JULY 17, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.087 CUBIC FOOT PER SECOND, BEING 0.01 CUBIC FOOT PER SECOND FROM EACH SPRING, AND 0.067 CUBIC FOOT PER SECOND FROM FIELD DRAIN TILE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversions are located within the NE¼ NE¼ of SECTION 31, T 1 S, R 34 E, W M.; Reservoir and field drain tile - 1170 feet South and 400 feet West Springs - 350 feet South and 340 feet West; 370 feet South and 380 feet West, all from the NE Corner of Section 31

The use hereunder shall conform to such reasonable rotation system as may be order by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent in case of rotation, for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from the reservoir constructed under Permit R-5037.
