CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

E.H. AND JESSE AND LAURA TAYLOR  
RUCH, OREGON 97530

confirms the right to use the waters of the APPLGATE RIVER, a tributary of the ROGUE RIVER, for IRRIGATION OF 39.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Page 523. The date of priority is 1908.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.80 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 10, T 39 S, R 3 W, W.M.; STURGIS OR HAMILTON DITCH.

A description of the place of use to which this right is appurtenant is as follows:

LYING WEST OF THE APPLGATE RIVER

This certificate describes that portion of the water right confirmed by Certificate 32899, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUL 02 1997, approving Transfer Application 7714.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
