CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAUL J. AND MARY LOU WILLARD  
ROUTE 1, BOX 76  
GERVAIS, OREGON

confirms the right to use the waters of A WELL in the WILLAMETTE RIVER BASIN for IRRIGATION OF 77.0 ACRES.

This right was perfected under Permit G-2360. The date of priority is APRIL 16, 1963. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.96 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE $\frac{1}{4}$  SE $\frac{1}{4}$ , AS PROJECTED WITHIN JONES DLC 61, SECTION 1, T 6 S, R 3 W, W.M.; 980 FEET SOUTH AND 600 FEET WEST FROM THE NE CORNER OF JONES DLC 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

BOTH AS PROJECTED WITHIN JONES DLC 61  
SECTION 12  
TOWNSHIP 6 SOUTH, RANGE 3 WEST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate describes that portion of the water right confirmed by Certificate 34914, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUL 21 1997, approving Transfer Application 7269

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
