CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of NORTH BRANCH CAMPBELL CREEK AND THE RESERVOIR CONSTRUCTED UNDER PERMIT R-4663, tributaries of the TUALATIN RIVER for the purpose of SUPPLEMENTAL IRRIGATION OF 26.8 ACRES.

This right was perfected under PERMIT 30882. The date of priority is JULY 1, 1965. The use is limited to 0.155 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 34, T 1 S, R 3 W, WM, namely: Creek - 1960 feet South and 460 feet West, Reservoir - 2380 feet South and 990 feet West, both from the NE Corner, SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4663, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 1 SOUTH, RANGE 3 WEST, W.M.

This certificate describes that portion of the water right confirmed by the prior Certificate 40830, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered JUL 22 1997.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610, pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
