CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO  
STANFIELD IRRIGATION DISTRICT

STANFIELD, OR. 97875

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER for IRRIGATION, DOMESTIC, and STOCK water of 148.5 acres.

This right was perfected under the Umatilla River Decree Volume 15 Page 433-435 in the name of Stanfield Irrigation District. The date of priority is MARCH 8, 1905. The amount of water to which this right is entitled is limited to an amount of water actually beneficially used and shall not exceed 1.86 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the Umatilla River.

The point of diversion is located as follows: 430 FEET NORTH AND 450 FEET EAST, FROM THE SOUTHWEST CORNER OF SECTION 31, BEING WITHIN LOT 4 (SW1/4 SW1/4) OF SECTION 31, TOWNSHIP 3 NORTH, RANGE 30 EAST, W.M. UMATILLA COUNTY.

the amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from MARCH 1 to NOVEMBER 1 and subject to the limitations of paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.

This certificate describes that portion of the water right confirmed by the Umatilla River Decree Volume 15 Page 433-435 in the name of Stanfield Irrigation District State Record of Water Rights, NOT modified by the provisions of an order of the Water Resources Director entered on 4-7 \_\_\_\_\_, 1998, and recorded in Special Order Volume 52, page 348, approving a petition by Stanfield Irrigation District under ORS 541.329.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
