CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of AN UNNAMED STREAM AND A DRAINAGE CANAL, a tributary of the COQUILLE RIVER, and COQUILLE RIVER, for the purpose of DOMESTIC USE FOR ONE FAMILY, STOCK AND IRRIGATION OF 168.3 ACRES.

This right was perfected under Permit 41180. The date of priority is MARCH 18, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.115 CUBIC FEET PER SECOND, BEING 0.005 CFS FOR DOMESTIC USE; 0.02 CFS FOR STOCK USE; AND 2.09 CFS FOR IRRIGATION FROM AN UNNAMED STREAM AND DRAINAGE CANAL WHEN AVAILABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE MADE UP BY APPROPRIATION FROM THE COQUILLE RIVER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

**POD 1** - (COQUILLE RIVER CONTROL STRUCTURE) LOT 2 (SW 1/4 NE 1/4), SECTION 3, T 28 S, R 13 W, W.M.; 1160 FEET NORTH AND 2110 FEET WEST FROM THE E 1/4 CORNER OF SECTION 3.

**POD 2** - (DIRECT FLOW IN CANAL) SE 1/4 NW 1/4, SECTION 11, T 28 S, R 13 W, W.M.; 980 FEET NORTH AND 1440 FEET EAST FROM THE W 1/4 CORNER SECTION 11.

**POD A** - (DIRECT POOL IN STREAM) NW 1/4 SW 1/4, SECTION 11, T 28 S, R 13 W, W.M.; 480 FEET SOUTH AND 1210 FEET EAST FROM THE W 1/4 CORNER SECTION 11.

**POD B** - (DIRECT FLOW ROCK POOL IN STREAM) SW 1/4 SW 1/4, SECTION 11, T 28 S, R 13 W, W.M.; 2410 FEET SOUTH AND 980 FEET EAST FROM THE W 1/4 CORNER SECTION 11.

**POD C** - (DUG OUT HOLE IN CHANNEL BEFORE CANAL) SE 1/4 NW 1/4, SECTION 11, T 28 S, R 13 W, W.M.; 950 FEET NORTH AND 1510 FEET EAST FROM THE W 1/4 CORNER SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NE 1/4 1.5 ACRES  
SECTION 10

NE 1/4 NW 1/4 40.0 ACRES  
NW 1/4 NW 1/4 38.2 ACRES AND STOCK  
SW 1/4 NW 1/4 39.3 ACRES  
SE 1/4 NW 1/4 18.6 ACRES AND STOCK  
NW 1/4 SW 1/4 30.7 ACRES, DOMESTIC AND STOCK  
SECTION 11  
TOWNSHIP 28 SOUTH, RANGE 13 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
