confirms the right to use the waters of the CITY OF FAIRVIEW WELL in the FAIRVIEW CREEK BASIN for MUNICIPAL USE.

This right was perfected under Permit G-443. The dates of priority are DECEMBER 19, 1956 for 0.11 cfs and FEBRUARY 7, 1957 for 0.89 cfs. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.0 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW% SW%, as projected within SCOTT DLC 39, SECTION 27, T 1 N, R 3 E, WM; 2450 FEET NORTH AND 70 FEET EAST FROM THE SW CORNER, SECTION 27.
