THIS CERTIFICATE ISSUED TO MILLS MINT FARMS, INC. ROUTE. 1, BOX 58 STANFIELD, OR. 97875

confirms the right to use the waters of A PIT WELL, a tributary of STANFIELD DRAIN (UMATILLA RIVER) for SUPPLEMENTAL IRRIGATION of 542.1 acres.

This right was perfected under Permit G-7094. The date of priority is JANUARY 7, 1997 for 1.84 cubic feet per second and FEBRUARY 23, 1977 for 4.93 cubic feet per second. The amount of water to which this right is entitled is limited to an amount of water actually beneficially used and shall not exceed 6.77 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the pit well.

The point of diversion is from a pit well located 660 feet North and 1350 feet East from center 1/4 corner of Section 33, being within the SE1/4 NE1/4, Section 33, Township 4 North, Range 29 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
