CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of COLUMBIA RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATING 82.6 ACRES.

The right has been perfected under Permit 43935. The date of priority is APRIL 6, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.07 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

EASTERN OREGON FARMING - SECTION 2, T 4 N, R 25 E, W.M.; S 86 0.22' 46" W. 2811 FEET FROM NE CORNER OF SECTION 2; WESTERN EMPIRIES CORP. - LOT 1 (SE 1/4 NE 1/4), SECTION 23, T 5 N, R 26 E, W.M.; 600 FEET NORTH AND 230 FEET WEST FROM THE EAST QUARTER CORNER OF SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
