CERTIFICATE OF WATER RIGHT (HB - 2153)

confirms the right to store the waters of UNNAMED STREAMS TRIBUTARIES OF WALLOWA RIVER  
IN TEN RESERVOIRS for LIVESTOCK AND WILDLIFE.

The right to store and use these waters was perfected under Reservoir Application R-75303.  
The date of priority is January 1, 1993. The amount of water entitled to be stored and  
used each year under this right is not more than 2.97 ACRE-FEET (AF),  
BEING 0.28 AF IN BRIGHT ROAD POND RESERVOIR, 0.17 AF IN JESS WADE SPRING  
RESERVOIR, 0.09 AF IN COYOTE POND RESERVOIR, 0.26 AF IN BRIGHT PLACE WELL  
RESERVOIR, 0.17 AF IN REDWATER POND RESERVOIR, 0.34 AF IN SPRING BRANCH  
RESERVOIR, 0.77 AF IN UPPER PASTURE RESERVOIR, 0.21 AF IN BIG HILL RESERVOIR, 0.5 AF  
IN ROCK POND RESERVOIR AND 0.18 AF IN BROWNIES II RESERVOIR.

above.
