confirms the right to store the waters of  
SPRINGS RUNOFF, TRIBUTARIES OF WALLOWA RIVER IN NINE RESERVOIRS  
for LIVESTOCK AND WILDLIFE.

The right to store and use these waters was perfected under Reservoir Application R-75683.  
The date of priority is January 1, 1993. The amount of water entitled to be stored and used each year under  
this right is not more than 9.67 ACRE-FEET (AF), BEING 0.44 AF IN RES 1, 8.3 AF IN RES 2, 0.22 AF  
IN RES 3, 0.11 AF IN RES 4, 0.05 AF IN RES 5, 0.09 AF IN RES 6, 0.10 AF IN RES 7, 0.28 AF IN  
RES 8, 0.08 AF IN RES 9.



listed above.
