confirms the right to store the waters of RUNOFF, A TRIBUTARY OF PINE TREE GULCH AND OK GULCH IN EIGHT RESERVOIRS for LIVESTOCK.

The right to store and use these waters was perfected under Reservoir Application R-80283. The date of priority is January 1, 1993. The amount of water entitled to be stored and used each year under this right is not more than 4.086 ACRE-FEET (AF), BEING 0.83 AF IN RES 14, 0.55 AF IN RES 15, 0.02 AF IN RES 16, 1.10 AF IN RES 17, 0.15 AF IN RES 18, 0.63 AF IN RES 1, 0.08 AF IN RES 6, 0.8 AF IN RES 13.

The right to store and use the water for the above purpose is restricted to beneficial use at the place of use listed above.

This certificate is issued to correctly describe the place of use and supersedes certificate 71868.
