CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Kent and Shannon Madison

Echo, Oregon 97826

confirms the right to use the waters of A WELL AND INFILTRATION TRENCH in the BUTTER CREEK BASIN for PRIMARY IRRIGATION OF 116.8 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 131.6 ACRES.

This right was perfected under Permit G-7612. The date of priority is JULY 13, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.25 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SE 1/4 NW 1/4, SECTION 31, TOWNSHIP 3 NORTH, RANGE 28 EAST, WM;
1620 FEET SOUTH AND 1060 FEET WEST FROM THE N 1/4 CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm changes in place of use and use approved by an orders of the Water Resources Director entered February 27, 1990 and August 10, 1993.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
