## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES TULLIS, JR. PENDLETON, OREGON 97801

confirms the right to use the waters of MCKAY CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 2.98 ACRES.

This right was perfected under Permit 5996. The date of priority is AUGUST 16, 1923. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.037 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW% SE%, SECTION 34, TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.; NORTH 34  $^{\circ}$  00' EAST 21.6 CHAINS FROM THE SOUTH% CORNER, SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE% NE% 2.98 ACRES SECTION 28 TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.
