CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TEEL IRRIGATION DISTRICT
32327 OREGON TRAIL ROAD
ECHO, OREGON 97826

confirms part of the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 4471.3 acres.

This right was perfected under Permit 25924. The date of priority is JUNE 27, 1958. This right is limited to 30.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:
SW 1/4 NE 1/4, SECTION 21, T 3 N, R 29 E, W.M.; WESTLAND CANAL - NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST, ~~2213.19~~ ^{2913.19} FEET FROM THE WEST 1/4 CORNER OF SECTION 21.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent), and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
