## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

TCDD M. DIMBAT Irrevocable TRUST KELLY L. MOLASH Irrevocable TRUST TONY AMSTAD, TRUSTEE ECHO, OREGON 97826

confirms the right to use the waters of WELLS 1 & 3, in the UMATILLA RIVER BASIN, for PRIMARY IRRIGATION OF 2.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 234.5 ACRES.

This right was perfected under Permit G-6339. The date of priority is OCTOBER 1, 1975. This right is limited to not more than 2.96 CUBIC FEET PER SECOND, being 1.48 CFS from EACH WELL, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE¼ SW¼, SECTION 16, T 3 N, R 29 E, W.M.;

WELL 1 - 850 FEET NORTH AND 750 FEET WEST; FROM S¼ CORNER SECTION 16 WELL 3 - 350 FEET NORTH AND 850 FEET WEST, FROM S¼ CORNER SECTION 16.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The diversion shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:0
