confirms the right to use the waters of BETZ WELLS NO. 2, in the UMATILLA RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 125.6 ACRES.

This right was perfected under Permit G-4048. The date of priority is DECEMBER 18, 1967. This right is limited to not more than 1.57 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE¼ NE¼, SECTION 28, T 3 N, R 28 E, W.M.; 1960 FEET SOUTH AND 80 FEET WEST FROM NE CORNER, SECTION 28.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
