CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PENDLETON SCHOOL DISTRICT 16-R 1207 FRAZIER AVENUE PENDLETON, OREGON 97801

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 27.7 ACRES.

This right was perfected under Permit 14412. The date of priority is MAY 31, 1940. This right is limited to not more than 0.35 CUBIC FOOT PER SECOND; if available at the original point of diversion, NE ¼ NE ¼, SECTION 9, T 2 N, R 32 E, W.M., 1287 FEET SOUTH AND 1023 FEET WEST FROM THE NE ¼ CORNER OF SECTION 9, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW ¼ NW ¼, SECTION 10, T 2 N, R 32 E, W.M.; 368 FEET SOUTH AND 740 FEET EAST FROM NW CORNER, SECTION 10.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW ¼ SW ¼ 18.7 Acres

SECTION 3

NE ¼ NE ¼ 5.8 Acres

SECTION 9

NW ¼ NW ¼ 3.2 Acres

SECTION 10

TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm an change in CHARACTER OF USE, POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered JULY 24,1992, approving Transfer 6694. The certificate supersedes Certificate 67298, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
