## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BEN INMAN 90067 TERRITORIAL ROAD JUNCTION CITY, OREGON 97448

confirms the right to use the waters of FERN RIDGE RESERVOIR, CONSTRUCTED UNDER APPLICATION NO. R-29397, PERMIT NO. R-1625, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 4.0 ACRES.

This right was perfected under Permit 26089. The date of priority is MARCH 26, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 8.6 ACRE FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE% SW%, AS PROJECTED WITHIN LASATER DLC 44, SECTION 8, T 17 S, R 5 W, W.M..

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to a diversion of not to exceed 2½ acre feet per acre or its equivalent for each acre irrigated during the irrigation season of each year, and shall be further limited to a total diversion of not to exceed 8.6 acre feet per year, and this permit is subject to the terms of Contract No. 14-06-100-1706 dated April 3, 1959.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE% SW% 4.0 ACRES AS PROJECTED WITHIN INMAN DLC 43 TOWNSHIP 17 SOUTH, RANGE 5 WEST, W.M.
