CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CORA B. CRUMP, ADMINISTRATRIX OF
ESTATE OF J.F. CRUMP, DECEASED
BUNCOM, OREGON

confirms the right to use the waters of the LITTLE APPELEGATE RIVER, a tributary of the APPELEGATE RIVER and supplemental supply from McCORMICK GULCH, a tributary of the LITTLE APPELEGATE RIVER, FOR IRRIGATION OF 6.2 ACRES AND STOCK USE AND SUPPLEMENTAL SUPPLY FOR IRRIGATION OF 6.2 ACRES, AND DOMESTIC AND STOCK USE FROM McCORMICK GULCH.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1872 for the LITTLE APPELEGATE RIVER and 1897 for McCORMICK GULCH.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.16 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

GILSEN AND GLEAVE DITCH - NW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 27, T 39 S, R 2 W,
W.M.

McCORMICK GULCH DITCH - SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 28, T 39 S, R 2 W,
W.M.

A description of the place of use to which this right is appurtenant is as follows:

NW $\frac{1}{4}$ SW $\frac{1}{4}$ 1.7 ACRES
SECTION 28

SE $\frac{1}{4}$ NE $\frac{1}{4}$ 2.0 ACRES
NE $\frac{1}{4}$ SE $\frac{1}{4}$ 2.5 ACRES

TOWNSHIP 39 SOUTH, RANGE 2 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 16393, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered ~~OCT 27 1997~~ , approving Transfer Application 7325.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
