CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALBERT AND LINDA ENYEART  
600 WEST 4TH ST  
COQUILLE, OREGON 97423

confirms the right to use the waters of SPRING 2, SPRING 5, AND NORTH FORK COQUILLE RIVER, tributaries of the COQUILLE RIVER, for DOMESTIC USE FOR ONE FAMILY, STOCKWATER, AND IRRIGATION OF 1.8 ACRES.

This right was perfected under Permit 36707. The dates of priority are OCTOBER 11, 1972 - FOR SPRINGS AND DECEMBER 28, 1972 - FOR NORTH FORK COQUILLE RIVER. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.035 CUBIC FOOT PER SECOND (CFS), BEING 0.005 CFS FROM SPRING 2 FOR DOMESTIC; 0.005 CFS FROM SPRING 5 FOR STOCKWATER; 0.01 CFS FROM SPRING 5 WITH ANY DEFICIENCY IN THE SUPPLY TO BE APPROPRIATED FROM THE NORTH FORK COQUILLE RIVER FOR IRRIGATION; AND 0.015 FROM NORTH FORK COQUILLE RIVER FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

RIVER - SW 1/4 SE 1/4, SECTION 24, 620 FEET NORTH AND 630 FEET EAST;  
SPRING 2 - SE 1/4 SE 1/4, 240 FEET NORTH AND 1700 FEET EAST; SPRING 5 - SE 1/4 SE 1/4, 200 FEET NORTH AND 1430 FEET EAST; ALL FROM SOUTH QUARTER CORNER OF SECTION 24, ALL LOCATED WITHIN SECTION 24, TOWNSHIP 27 SOUTH, RANGE 12 WEST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
