CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRANCIS GAIL HURD 5341 UMPQUA HIGHWAY DRAIN, OREGON 97435

confirms the right to use the waters of AN UNNAMED STREAM AND TWO RESERVOIRS CONSTRUCTED UNDER PERMIT R-7917, a tributary of PASS CREEK, for DOMESTIC USE FOR ONE FAMILY, DOMESTIC USE IN A SHOP BUILDING, AND IRRIGATION OF 12.6 ACRES.

This right was perfected under Permit 44359. The date of priority is JUNE 5, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.17 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FOR DOMESTIC USE FROM THE UNNAMED STREAM, AND 0.16 CFS FROM THE UNNAMED STREAM AND RESERVOIR FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

UNNAMED STREAM - SW 1/4 NW 1/4, SECTION 31, T 21 S, R 4 W, W.M.; 1500 FEET SOUTH AND 100 FEET EAST; FROM THE NW CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year FROM DIRECT FLOW AND STORAGE.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NE 1/4 9.0 ACRES, DOMESTIC AND SHOP NW 1/4 NE 1/4 0.4 ACRE SE 1/4 NE 1/4 3.2 ACRES SECTION 36 TOWNSHIP 21 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
