## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN F. MADISON ROUTE 1, BOX 25-C ECHO, OREGON 97826

Cert. No. 75653

confirms the right to use the waters of A WELL in the BUTTER CREEK BASIN for IRRIGATION OF 187.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 138.9 ACRES.

This right was perfected under Permit G-3834. The date of priority is SEPTEMBER 15, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.45 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SE 1/4 SE 1/4, SECTION 24, TOWNSHIP 3 NORTH, RANGE 27 EAST, W.M.; 1260 FEET NORTH AND 2530 FEET EAST FROM THE S 1/4 CORNER, SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
