CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES D. RODINE 14658 UPPER COW CREEK ROAD AZALEA, OREGON 97410

confirms the right to use the waters of MAPLE CREEK AND COW CREEK, tributaries of the UMPQUA RIVER, for PRIMARY AND SUPPLEMENTAL IRRIGATION OF 32.5 ACRES, SUPPLEMENTAL IRRIGATION OF 12.0 ACRES, AND PRIMARY IRRIGATION OF 5.0 ACRES.

This right was perfected under Permit 41570. The date of priority is OCTOBER 11, 1976 - FOR COW CREEK AND JUNE 8, 1977 - FOR MAPLE CREEK. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.69 CUBIC FOOT PER SECOND (CFS); BEING 0.41 CFS FROM MAPLE CREEK WITH ANY DEFICIENCY IN THE SUPPLY TO BE APPROPRIATED FROM COW CREEK PROVIDED THE TOTAL QUANTITY OF WATER SHALL NOT EXCEED 0.46 CFS; 0.06 CFS FROM COW CREEK FOR PRIMARY IRRIGATION; AND 0.17 CFS FROM COW CREEK FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

MAPLE CREEK DIVERSION 1 - NW 1/4 SE 1/4, 2240 FEET NORTH AND 3000 FEET EAST; MAPLE CREEK DIVERSION 2 - NE 1/4 SW 1/4, 1540 FEET NORTH AND 2270 FEET EAST; COW CREEK DIVERSION - SE 1/4 SW 1/4, 690 FEET NORTH AND 2250 FEET EAST, ALL FROM THE SOUTHWEST CORNER OF SECTION 32, ALL LOCATED WITHIN SECTION 32, T 31 S, R 3 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SEVENTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
