CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN F. PUGH P.O. BOX 94 BROGAN, OREGON 97903

confirms the right to use the waters of TWO WELLS, tributary of WILLOW CREEK BASIN for IRRIGATION of 39.80 and SUPPLEMENTAL IRRIGATION OF 157.20 ACRES OF LAND.

This right was perfected under Permit U-185. The date of priority is JUNE 24, 1946.

The use is limited to 3.00 CUBIC FEET PER SECOND or it's equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

- #15- Pugh Well: 350 feet South and 30 feet East from the NW corner from Section 24, being within the NW¼NW¼, Section 24, Township 15, South, Range 42 East, W.M.
- #22- Pugh Well #1: 1220 feet South and 1200 feet East from the NW corner Section 24, being within the NW¼NW¼, Section 24, Township 15 South, Range 42 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second or its equivalent for each acre irrigated prior to May 1, and ONE EIGHTIETH or its equivalent for each acre irrigated during the remainder of the irrigation season, and shall be further limited to a diversion of not to exceed 3.00 cfs.

A description of the place of use to which this right is appurtenant is as follows:
