CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL # 3, tributary of WILLOW CREEK BASIN (SNAKE RIVER) for IRRIGATION of 39.90 and SUPPLEMENTAL IRRIGATION of 32.10 ACRES OF LAND.

This right was perfected under Permit G-1888. The date of priority is JUNE 29, 1961.

The use is limited to 0.90 CUBIC FOOT PER SECOND or it's equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

#13- Pugh Well: 30 feet South and 1290 feet West from the center corner of Section 14, being within the NE4SW4, Section 14, Township 15 Sough, Range 42 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
