CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ORCHARDS WATER COMPANY P.O. BOX 5 JAMIESON, OREGON 97909-0005

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for IRRIGATION of 19.80 ACRES OF LAND.

This right was perfected under Permit 42210. The date of priority is APRIL 8, 1977.

The use is limited to 0.50 CUBIC FOOT PER SECOND or it's equivalent in case of rotation, measured at the point of diversion from the source, if available at the original point of diversion, NE¼NE¼, / SECTION 25, Township 15 South, Range 42 East, W.M.; HEVNER DITCH - 140 FEET EAST AND 890 FEET WEST FROM NE CORNER SECTION 25.

The point of diversion is located as follows:

1340 feet South and 100 feet East from the NW corner of Section 30, being within the SW¼ NW¼, Section 30, Township 15 South, Range 43 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The use shall confirm to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion to the water right confirmed by certificate 62352, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on $\frac{4-7-98}{2}$, and recorded in Special Order Volume 52, Page 322; approving a petition by ORCHARDS WATER COMPANY under ORS 541.329 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
