CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DRY GULCH DITCH COMPANY
ROUTE 1, BOX 102A
RICHLAND, OR 97870

confirms the right to use the waters of natural flow and water coming into as waste from irrigation of land, also waste water from Dry Gulch Ditch from Eagle Creek, from Guyer Gulch or Draw, a tributary of Powder River for SUPPLEMENTAL IRRIGATION of 26.0 ACRES.

This right was perfected under Permit 7948 and has a date of priority of May 26, 1927.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.30 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

- #7 Guyer Gulch NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 20, T9S, R45E, W.M.; 360' South and 260' East from the East quarter corner of Section 19, T9S, R45E, W.M.
- #8 Guyer Gulch NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 20, T9S, R45E, W.M.; 520' South and 50' East from the East quarter corner of Section 19, T9S, R45E, W.M.

The amount of water used for irrigation is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent, for each acre irrigated during the irrigation season of each year. The right herein granted to waste water is limited to the water available at the points of diversion and does not carry with it the right to divert water from the stream from which the waste water is diverted nor the right to require the wasteful use of water by others.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate supersedes Certificate 10155 and confirms an order of the Water Resources Director entered on FEB 16 1999 approving a petition by Dry Gulch Ditch Company under ORS 541.329 for mapping water rights within a district.
