CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DRY GULCH DITCH COMPANY ROUTE 1, BOX 102A RICHLAND, OR 97870

confirms the right to use the waters of TIMBER CANYON (aka LOWER TIMBER CANYON) & GUYER GULCH tributaries of POWDER RIVER, a tributary of SNAKE RIVER, for SUPPLEMENTAL IRRIGATION OF 40.20 ACRES.

This right was perfected under Permit 13139.

The date of priority is SEPTEMBER 8, 1938.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.00 CUBIC FOOT PER SECOND, being 0.17 cfs from Little Timber Canyon (aka Timber Canyon) and 0.83 cfs from Guyer Gulch, or the equivalent in case of rotation, measured at the points of diversion from the sources.

The points of diversion are located as follows:

#7	Guyer Gulch	NW¼ SW¼, Section 20, T9S, R45E, W.M.; 360' South and 260' East from the East quarter corner of Section 19, T9S, R45E, W.M.
#9	Guyer Gulch	NE ¹ / ₄ SE ¹ / ₄ , Section 19, T9S, R45E, W.M.; 1175' South and 550' West from the East quarter corner of Section 19, T9S, R45E, W.M.
#10	Timber Canyon (aka Lower Timber Canyon)	NW ¹ / ₄ NW ¹ / ₄ , Section 30, T9S, R45E, W.M.; 625' South and 1125' East from the Northwest corner of Section 30, T9S, R45E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or the equivalent, for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall conform to any reasonable rotation system as may be ordered by the proper state officer.
