## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALA VISTA ORCHARD MEDFORD, OREGON 97501

confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary of the ROGUE RIVER, for IRRIGATION AND SUPPLEMENTAL IRRIGATION OF 121.7 ACRES.

This right was perfected under Permit 15987. The date of priority is SEPTEMBER 9, 1944. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.53 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW1/4 SW1/4, SECTION 3, T 36 S, R 1 W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre-feet for each acre irrigated during the irrigation season from April 2 to October 31 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Permit 6396 was not perfected for all lands described by Certificate 15781 as supplemental. This right was perfected for irrigation on those lands for which Permit 6396 was not perfected and for supplemental irrigation on those lands for which Permit 6396 was perfected.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 Capentaining to forfeiture or abandonment.
