confirms the right to use the waters of McKAY CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION of 22.0 acres.

This right was perfected under Permit 5996. The date of priority is August 16, 1923. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.275 CUBIC FOOT PER SECOND, if available at the original point of diversion, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as described below.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
