CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

A. GUNTHER ROUTE 3, BOX 157 OREGON CITY, OR 97045

confirms the right to use the waters of CAUFIELD CREEK and RESERVOIR CONSTRUCTED UNDER PERMIT NO. R-976, tributaries of BEAVER CREEK, a tributary of the WILLAMETTE RIVER for the purposes of IRRIGATION of 18.5 ACRES and SUPPLEMENTAL IRRIGATION OF 20.0 ACRES.

This right was perfected under PERMIT 18804. The date of priority is FEBRUARY 1, 1949. The amount of water to which such right is entitled for the purpose aforesaid is limited to an amount actually beneficially used for said purpose, and shall not exceed 0.481 CUBIC FOOT PER SECOND, being 0.231 CUBIC FOOT PER SECOND from CAUFIELD CREEK for IRRIGATION and 0.25 CUBIC FOOT PER SECOND from RESERVOIR for SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW¼ SW¼, as projected within R. CAUFIELD DLC 53, SECTION 9, TOWNSHIP 3 SOUTH, RANGE 2 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ ACRE FEET per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from a reservoir constructed under Permit No. R-976; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
