## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HUDSPETH LAND & LIVESTOCK C/O FRED HUDSPETH, PARTNER PRINEVILLE, OREGON 97754

confirms the right to use the waters of THE CROOKED RIVER, a tributary of THE DESCHUTES RIVER, for IRRIGATING 108.5 ACRES.

This right was perfected under Permit 23259. The date of priority is March 29, 1955. This right is limited to 1.42 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE½ SE½, Section 21, T. 14 S., R. 15 E., W.M.; 1070 feet North and 70 feet West from the SE corner of Section 21.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by Certificate 29104, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Director entered of <u>FB 1 8 1998</u>98, and recorded in Special Order Volume 52, Page <u>|41|</u>, approving a petition by People's Irrigation Company under ORS 541.325 to 541.333 for mapping water rights within a district and supersedes certificate of water right numbered 29104.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.
