CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NEW EDUCATION FOUNDATION 785 BARTON ROAD GLENDALE, OR 97442

confirms the right to use the waters of TWO RESERVOIRS CONSTRUCTED UNDER PERMIT R-5598, tributaries of WOODFORD CREEK, for SUPPLEMENTAL IRRIGATION OF 1.2 ACRES.

This right was perfected under Permit 34948. The date of priority is JULY 1, 1970. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.4 ACRE-FOOT (AF) STORED WATER ONLY, BEING 0.1 AF FROM RESERVOIR 1 AND 0.3 AF FROM RESERVOIR 3, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

RESERVOIR 1 - NE 1/4 SW 1/4, SECTION 32, T 32 S, R 5 W, W.M.; 3550 FEET SOUTH AND 2450 FEET EAST FROM THE NW CORNER OF SECTION 32.

RESERVOIR 3 - SE 1/4 NW 1/4, SECTION 32, T 32 S, R 5 W, W.M.; 1320 FEET SOUTH AND 1580 FEET EAST FROM THE NW CORNER OF SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

RESERVOIR 1 RESERVOIR 3

NW 1/4 NW 1/4 0.3 ACRE SW 1/4 NW 1/4 0.3 ACRE

NE 1/4 SW 1/4 0.6 ACRE

SECTION 32 TOWNSHIP 32 SOUTH, RANGE 5 WEST W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
