CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID L. AND RITA F. HOGAN

TILLAMOOK, OREGON 97141

confirms the right to use the waters of 2 WELLS in the FORT ROCK BASIN for IRRIGATION OF 257.5 ACRES.

This right was perfected under Permit G-9127. The date of priority is JANUARY 13, 1981. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.22 CUBIC FEET PER SECOND, BEING 1.61 CFS FROM EACH WELL or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW¼ NE¼, SW¼ SE¼, SECTION 26, T 26 S, R 16 E, W.M.; WELL 1 - 3960 FEET NORTH AND 1300 FEET EAST, WELL 2 - 1310 FEET NORTH AND 1300 FEET EAST, BOTH FROM THE S¼ CORNER, SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
