CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES T. AND RENATE L. PANCAKE

confirms the right to use the waters of 2 WELLS in the FORT ROCK BASIN for IRRIGATING 71.9 ACRES.

This right was perfected under Permit G-10043. The date of priority is MARCH 22, 1983. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.9 CUBIC FOOT PER SECOND, being 0.42 cfs from WELL 1 and 0.48 cfs from WELL 2, or its equivalent in case of rotation, measured at the well.

The well is located as follows: NE¼ SE¼, SW¼ SE¼, SECTION 10, T 28 S, R 16 E, WM; WELL 1 - 310 FEET NORTH AND 1340 FEET WEST; WELL 2 - 1380 FEET NORTH AND 1260 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate describes that portion of the water right confirmed by Certificate 64037, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 20 1998, approving Transfer Application 7858.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
