CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W.F. ZIMMERMAN, R.L. SMITH AND HAROLD BARTSCH
PENDLETON, OREGON 97801

confirms the right to use the waters of MCKAY CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 15.51 ACRES.

This right was perfected under Permit 14294. The date of priority is APRIL 13, 1940. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.294 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

W.F. ZIMMERMAN - SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 21, T 2 N, R 32 E, WM;
SOUTH 28° 10' WEST, 1627 FEET FROM THE NE CORNER OF THE NW $\frac{1}{4}$, SECTION 21;

C.R. SMITH - NE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 21, T 2 N, R 32 E, WM; 694 FEET AND 1929 FEET EAST FROM THE NW CORNER, SECTION 21;

HAROLD BARTSCH - SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 21, T 2 N, R 32 E, W.M.; 2640 FEET SOUTH AND 2170 FEET EAST FROM THE NW CORNER, SECTION 21;

HAROLD BARTSCH, successor to F.L. INGRAM - SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 21, T 2 N, R 32 E, WM; NORTH 50° 30' WEST, 470 FEET FROM THE CENTER OF SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate describes that portion of the water right confirmed by Certificate 53298, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 25 1998 , approving Transfer Applications 7168, 7665 and 7709.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
