## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLAYTON M. AND SUSAN BRISCOE 35773 CUNNINGHAM ROAD ECHO, OR 97826

confirms the right to use the waters of A WELL, tributary of the UMATILLA RIVER, for IRRIGATION OF 3.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 8.5 ACRES.

This right was perfected under Permit G-910. The date of priority is JULY 8, 1958. The amount of water to which this right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said puposes, and shall not exceed 0.15 CUBIC FOOT PER SECOND, BEING 0.044 CUBIC FOOT PER SECOND FOR IRRIGATION, AND 0.106 CUBIC FOOT PER SECOND FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located within the SW¼ NE¼ of SECTION 6, T 2 N, R 30 E, W M.; 650 FEET NORTH AND 375 FEET EAST FROM THE CENTER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent in case of rotation, for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

PRIMARY IRRIGATION SW¼ NE¼ 3.3 ACRES

SUPPLEMENTAL IRRIGATION SW'4 NE'4 8.5 ACRES

SECTION 6 TOWNSHIP 2 NORTH, RANGE 30 EAST, W.M.

This certificate is issued to confirm the right modified by provisions of an order diminishing the right recorded at Special Order Volume 52, Page 313, and supersedes Certificate 30132, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
