CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MATILDA McCALLISTER
PRINEVILLE, OR 97754

confirms the right to use the waters of SQUAW CREEK, a tributary of the DESCHUTES RIVER, for the IRRIGATION OF 214.15 ACRES AND SUPPLEMENTAL IRRIGATION OF 4.75 ACRES

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 1, at page 471. The date of priority is 1901.

The amount of water to which such right is entitled and hereby confirmed, for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose and shall not exceed 4.378 CUBIC FEET PER SECOND, BEING 4.283 CUBIC FEET PER SECOND FOR IRRIGATION AND 0.095 CUBIC FOOT PER SECOND FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer.

A description of the lands irrigated under such right, and to which the water right hereby confirmed is appurtenant is as follows:

This certificate is issued to confirm the right modified by provisions of an order diminishing the right recorded at Special Order Volume 52, Page 314, and supersedes Certificate 75221, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
