CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SEAWIND FARMS, INC. P.O. BOX 242 SIXES, OREGON 97476

confirms the right to use the waters of BIG CREEK AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-8449, tributaries of FLORAS LAKE, for TEMPERATURE CONTROL, IRRIGATION AND FLOOD HARVESTING ON 57.47 ACRES.

This right was perfected under Permit 46806. The date of priority is FEBRUARY 25, 1982. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 8.6 CUBIC FEET PER SECOND (CFS), BEING 8.6 CFS FOR TEMPERATURE CONTROL, 1.44 CFS FOR IRRIGATION AND 2.87 CFS FOR FLOOD HARVESTING, PROVIDED THE TOTAL DIVERTED DOES NOT EXCEED 8.6 CFS CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW½ NW½, SECTION 21, T 31 S, R 15 W, W.M.; 1640 FEET SOUTH AND 200 FEET EAST FROM THE NW CORNER OF SECTION 21.

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For flood harvesting or pest control, 0.05 cubic foot per second per acre; For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 67225, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director APR 1 3 1998 _____, approving Transfer Application entered ___ 7215.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
