CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. EUGENE SCOTT ROUTE 1, BOX 88 COVE, OR 97824

confirms the right to use the waters of MILL CREEK, a tributary of GRANDE RONDE RIVER, for IRRIGATION OF 5.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 164.0 ACRES.

This right was perfected under Permit 31925. The date of priority is AUGUST 31, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.11 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW¼ SW¼, SECTION 24, T 3 S, R 40 E, WM; 180 FEET NORTH AND 560 FEET EAST FROM SW CORNER, SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
