CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SUCCESSORS TO SQUAW CREEK IRRIGATION COMPANY

confirms the right to use the waters of SQUAW CREEK, a tributary of THE DESCHUTES RIVER, for IRRIGATING 720.8 ACRES AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 471. The date of priority is NOVEMBER, 1904.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 14.42 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

Plainview Ditch - SW¼ SE¼, Section 28, T. 15 S., R. 10 E., W.M.; 710 feet North and 2640 feet West from the Southwest Corner of Section 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.
