CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the LAMBERT SLOUGH BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 102.5 ACRES.

The right has been perfected under Permit G-7205. The date of priority is FEBRUARY 22, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.92 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

LOT 7 (SW 1/4 NW 1/4), SECTION 15, T 5 S, R 3 W, W.M.; 2180 FEET SOUTH & 1300 FEET EAST FROM NW CORNER SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right, and to which such right is appurtenant, is as follows:

ALL AS PROJECTED WITHIN DLC 56

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
